Appeal against US District Judge Leonie Brinkema  
order to seal document read in Open Court.

ALLAH v AKBAR, I, slave of ALLAH, Zacarias Moussawi  
attach the US District Judge Leonie Brinkema order  
to seal document belonging to my defense presentation at  
the hearing of the 22 April 2002.

This order prevents the publication of documents  
essential for the complete and comprehensive apprehension  
of my defense relating to the issue of the hearing  
and the case. These material expose unequivocally  
the hostile and distrustful nature of my relations  
with the former devious government lawyer appointed  
, their utter ignorance of the case and their self confess  
inability to search or understand the case without  
my collaboration. In other words, their ineffective  
assistance of course defense counsel.

Therefore this court of Appeal must order US  
District Judge Leonie Brinkema to unseal (137)  
these documents. Moreover, due to the fact that  
access to third party is prohibited under the

The conditions of my isolation (See SAM) and that ~~there~~ <sup>there</sup> be no lawyer, this court must order that all document ~~not~~ <sup>relating</sup> released by me should be release to the public.

No security reason can be claim because I do not and will not have access to US National Security documents.

Being under complete isolation (no access to the party) and having no lawyer, this sealing order will denied me the US right to a public, fair and complete defense for my trial.

## Legal Argument.

The US Sixth Amendment claims:

" in all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial."

US District Judge Leonie Brinkema denied me a public trial by sealing document read case partly read in open court. ( direct quotation, verbatim )

The Supreme Court stated

" Under the Due Process clause of the Fourteenth Amendment criminal prosecution must comport with prevailing notions of fundamental fairness. We have long interpreted this standard of fairness to require that criminal defendant be afforded a meaningful opportunity to present a complete defense."

US District Judge Leonie Brinkema is defying any concept of fairness by making available to the government document which will be used against me and by specifically sealing document which enable me to mount an effective and complete defense.

Action.

- Unsealing of the document relating to the hearing of 22 April 2002, whether alluded to or repeated verbatim.
- Restriction on sealing order to clear security reasons and excluding completely document produce by the defendant who do not have access to National Security Document
