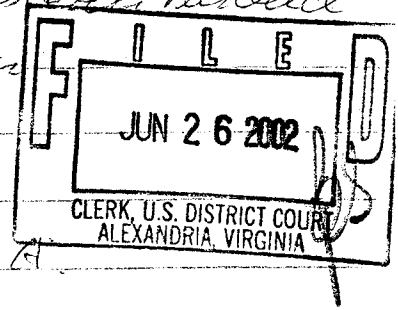

Motion to oppose the Classification  
of this case as complex and for the  
convening of hearing to determine how  
this Joint Motion between prosecution and
