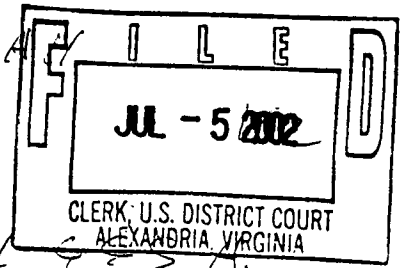

Vicious Tactics: For more than a week now the FBI is keeping my letter to the European Court of Justice and Parliaments Motion for Freedom of Justice and Fairness

Or they might claim that I committed suicide
