

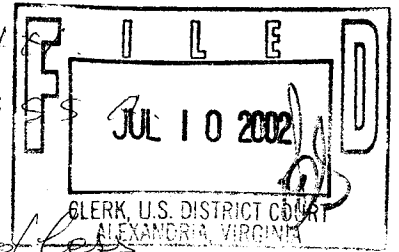

Legal Argument.

A court through its supervisory power over the Grand Jury, can direct that certain evidence be presented to a Grand Jury only when the failure to do so would result in a clear deprivation of due process or manifest miscarriage of Justice.

Taking account of the testimony of Coleen Rowley, the Refusal by the FBI to specifically certify that they were not conducting a surveillance operation and the Classified conversation between AL ATTAS and the Imam of Norman ("I heard you were going on Jihad").
