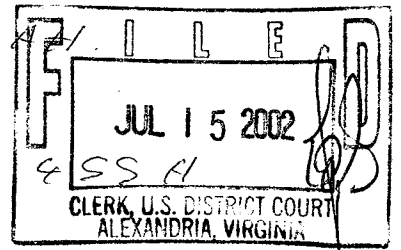


IN THE NAME OF ALLAH
