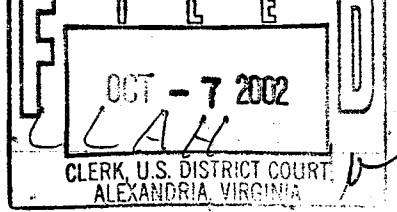

The same is valid concerning

know the purpose of the Malaysian
meeting.

This is a circumstantial case so Akeel Zulfikar
and Kamran Binalshih must be
interviewed first so I can develop my
defense to show that my activities
were not linked to O.L.L.
