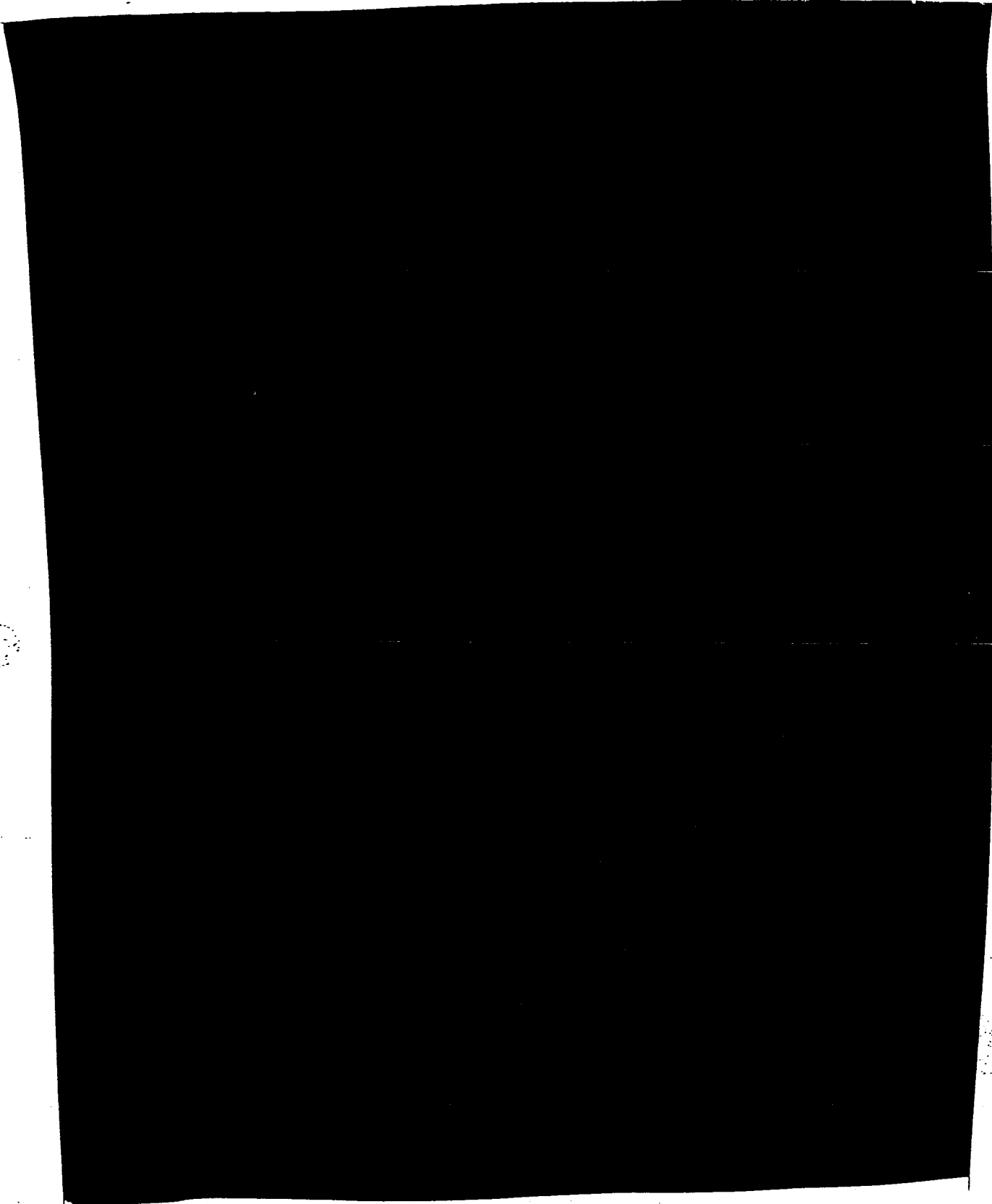
On October 16, 2002, pro se defendant Zacarias Moussaoui moved this Court
