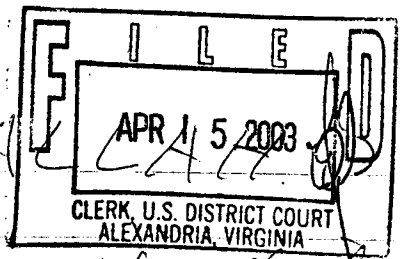

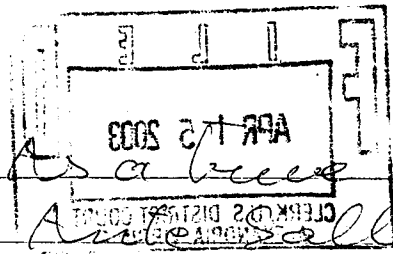
VERONICA MITCHELL:
