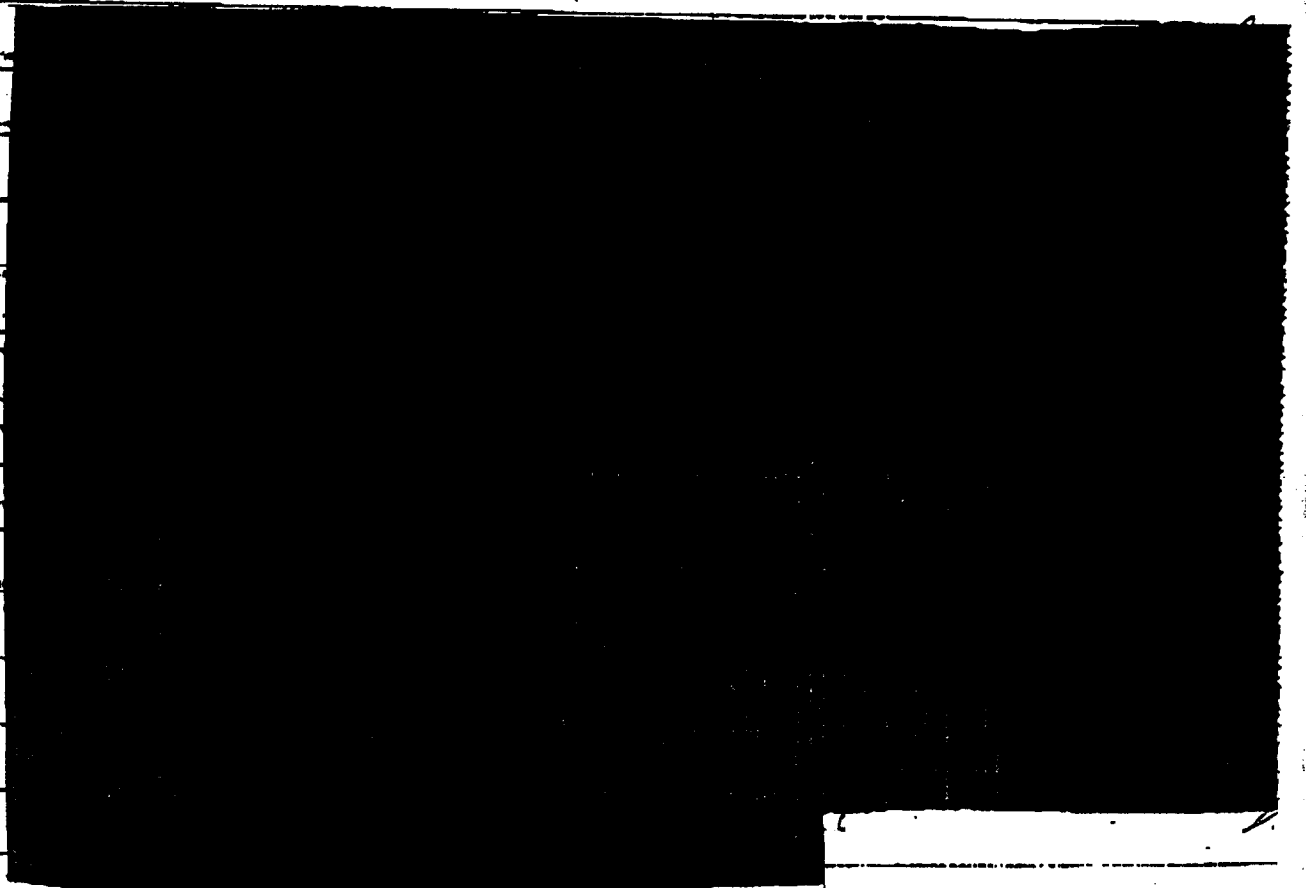
Indeed if Moushomi was ~~not~~ in charge of his personal national security will be greatly improved.


