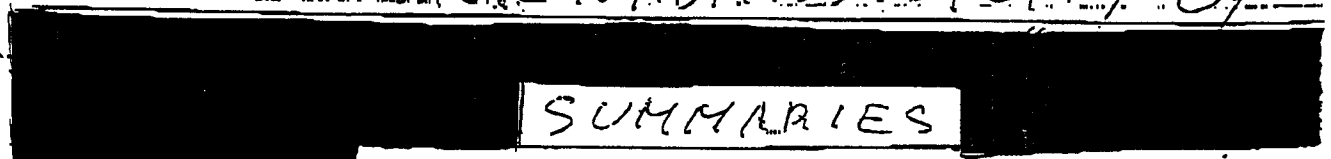

Usually classified information are information in the hand of the Justice Department that have serious national security value

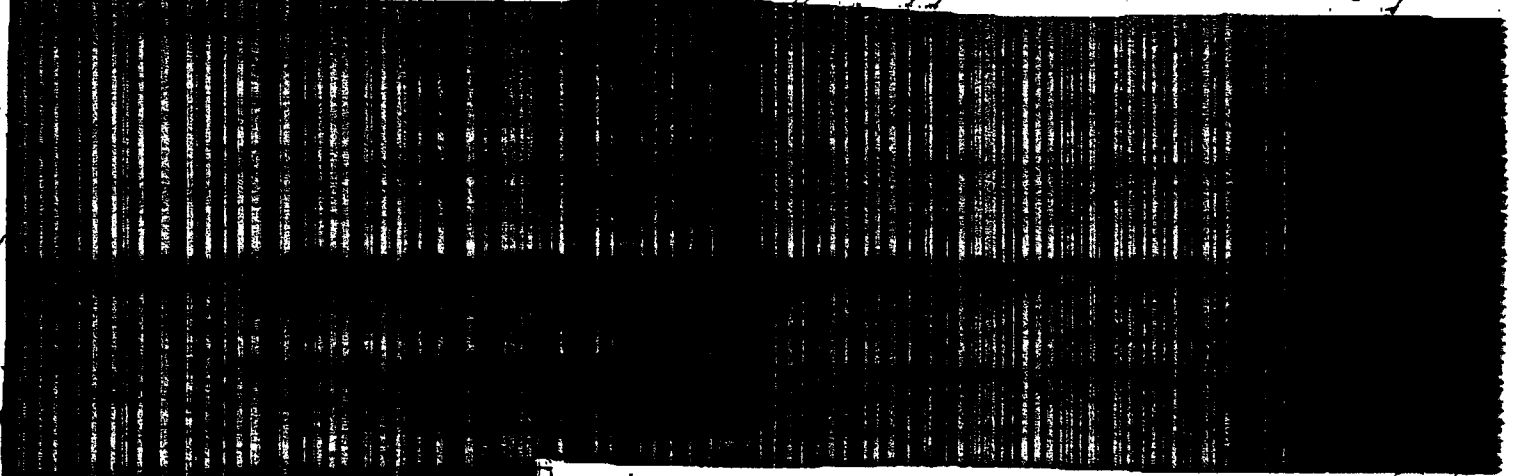
