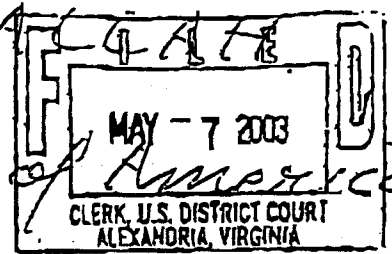

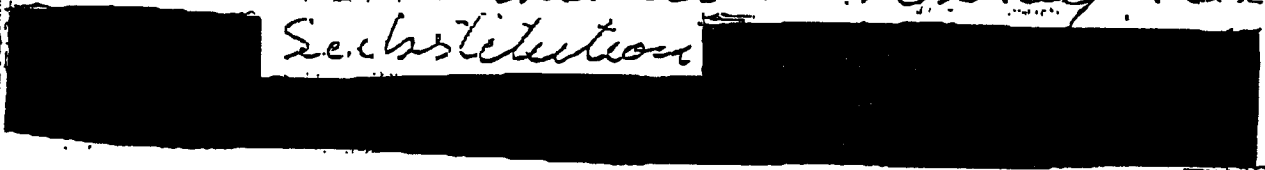

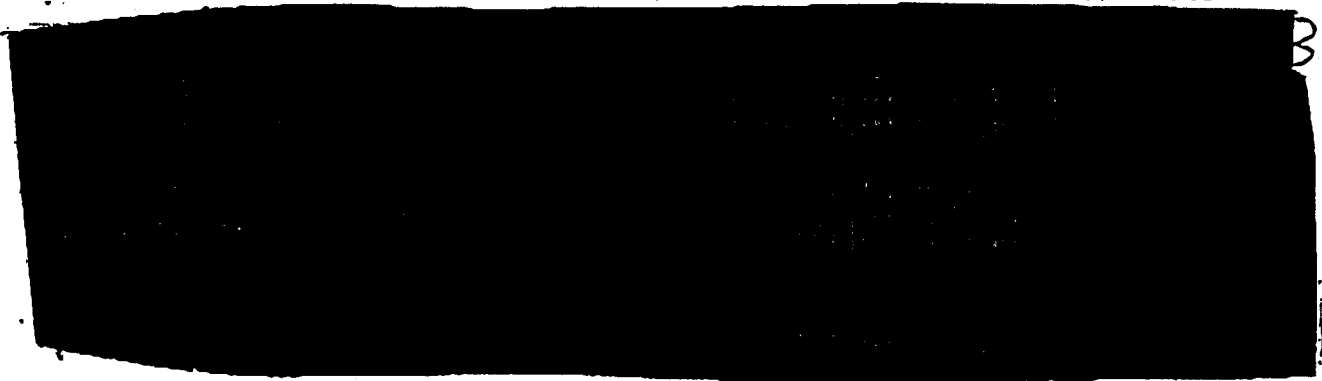

 Persian was the Ring leader.

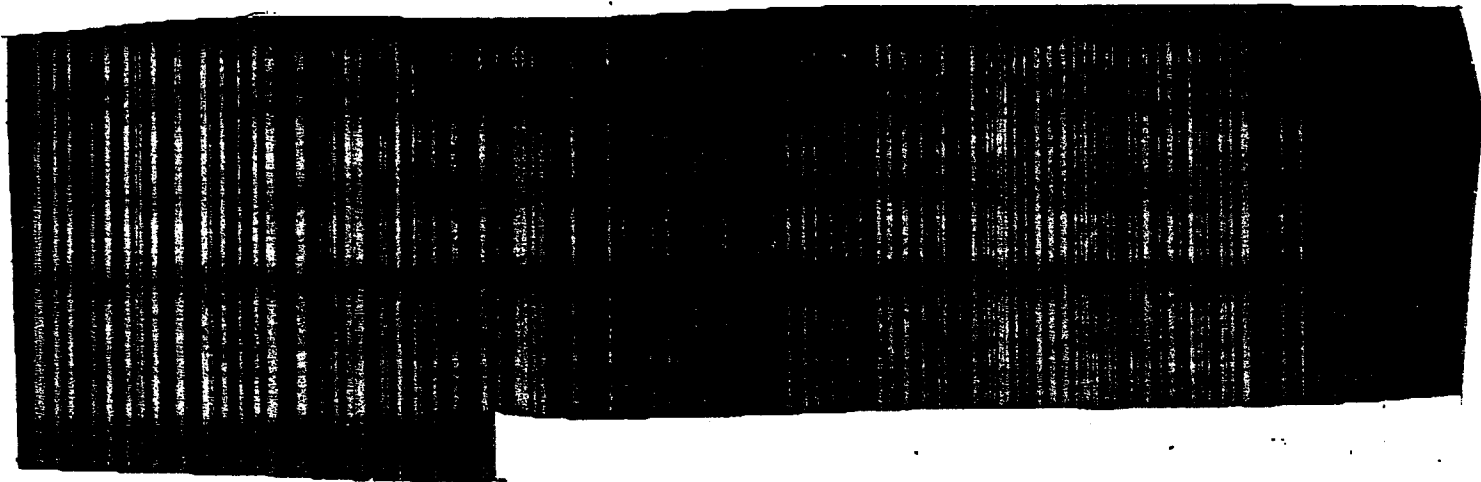
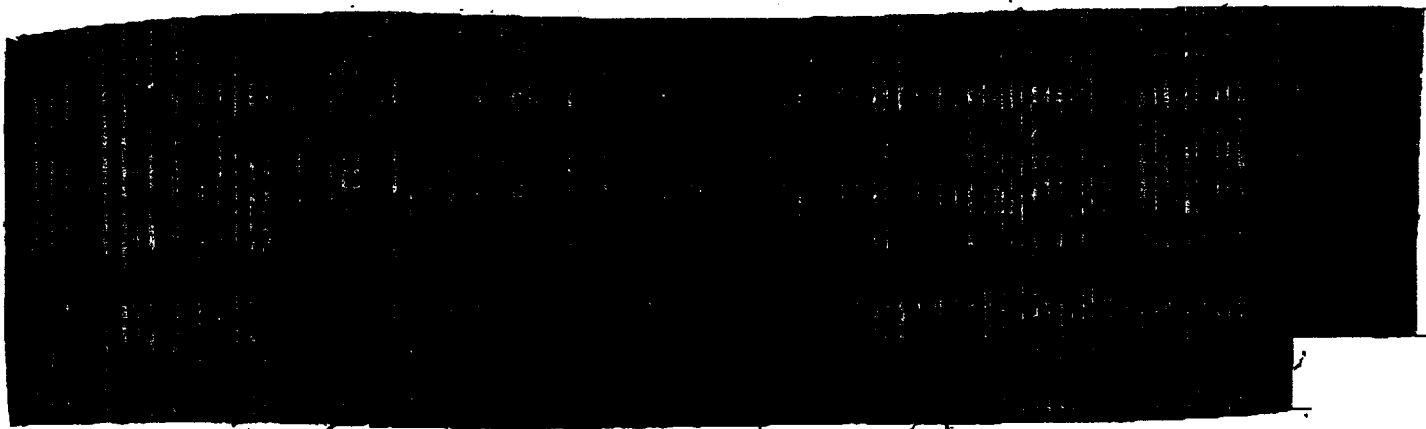
