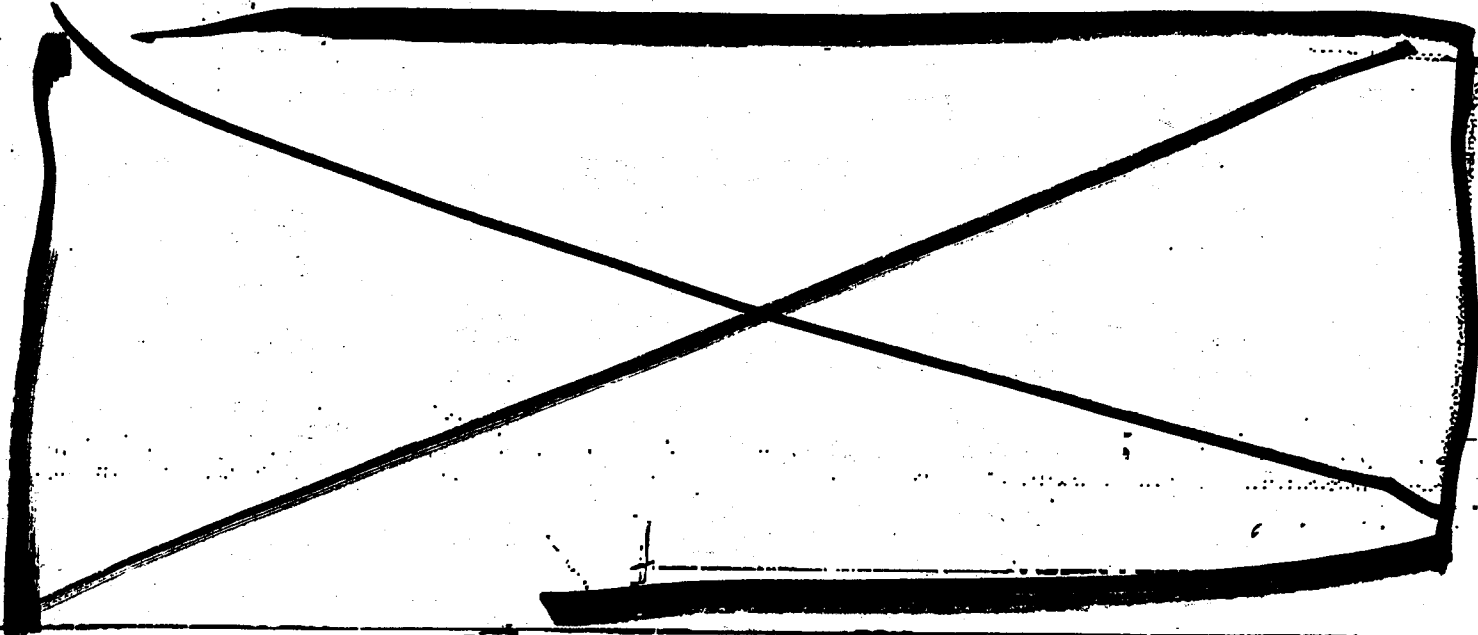

As the United States has no honor and no shame they are never afraid of ridicule or contradictions or paradox.

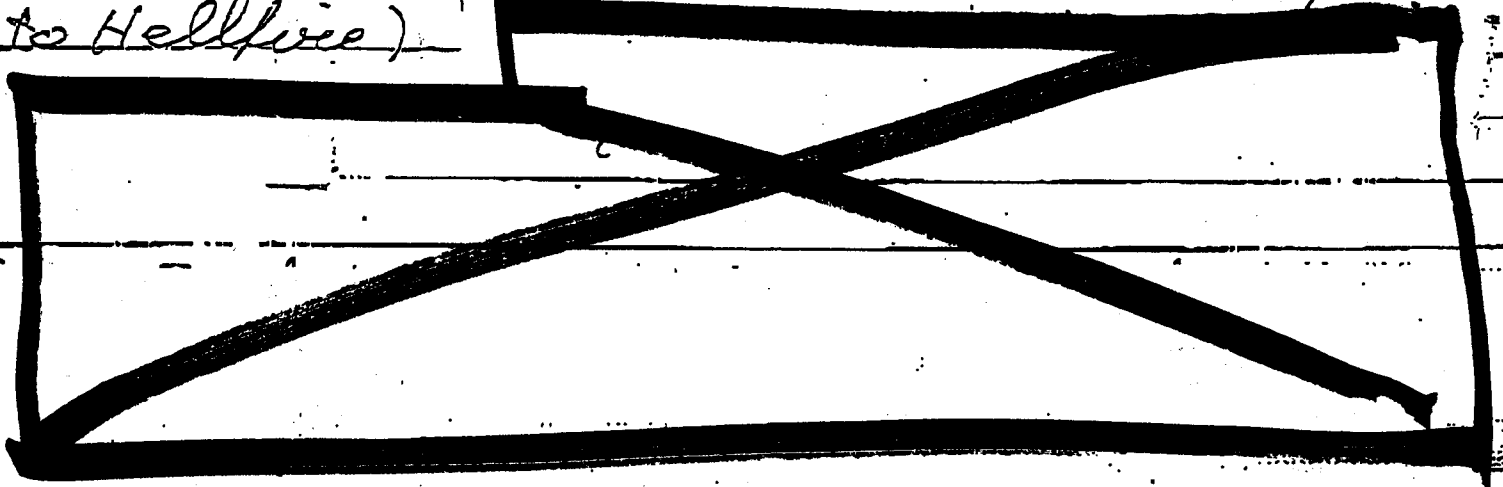

First, anybody will say "let see what [redacted] has to say about the 5th."

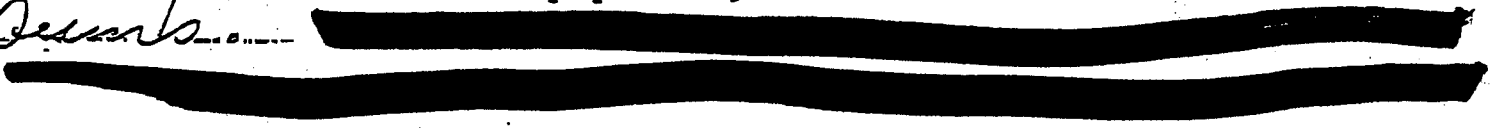
