## <u>DEFENDANT'S MOTION TO PRESERVE AND OBTAIN VIDEOTAPES, REPORTS</u> **AND MEMORANDA OF JUNE 10, 2004**

The Defendant, Zacarias Moussaoui, by and through his counsel and pursuant to the Court's Order of June 18, 2004 (dkt. no. 1174), advises the Court that the videotape which was obtained by the Marshal's Office and is the subject of the Order, may be needed as evidence and asks the Court to order that the tape be retained in the Court's file, under seal,<sup>2</sup> and made a part of the record.<sup>3</sup>

Further, after having viewed the videotape and communicated with Mr. Moussaoui on the matter, Defendant further moves for an order directing the Alexandria Sheriff's Office and the United States Marshal's Service to produce to the Court and make available to counsel of record any reports or memoranda regarding the events

The undersigned has been informed that the videotape the Marshal obtained is a copy of the original (master) tapes that are still in the possession of the Sheriff's Office. Defense counsel have not viewed these original tapes which record twelve or twenty-four hours of material and are changed regularly. In order to ensure that the record is complete and to ensure the authenticity of the copy in the Marshal's possession, Defendant requests that the original (master) videotapes also be placed in the Court's file, under seal, and that these original tapes be made available for viewing by counsel of record and/or members of their respective teams.
