inappropriate to his level of aviation experience. Subsequent investigation revealed that he is an Islamic fundamentalist with ties to the Chechen Mujihadeen.

[REDACTED] Moussaoui was accompanied to Minnesota by Hussein Ali Hassan Al-Attas, DPOB 01/22/1978 in Riyadh, Saudi Arabia. Al-Attas claims that he accompanied Moussaoui to Minnesota "as a friend" and that he had no knowledge of what Moussaoui intended to do upon completion of his flight training. When interviewed, Al-Attas admitted that he may have been aware of a terrorist plan on the part of Moussaoui, but claimed that since this was not consistent with his beliefs, he chose not to hear it and was therefore unable to provide any details.

[REDACTED] During an interview conducted on the evening of 08/15/2001, Al-Attas consented to a search of his personal effects. Included among these in an unaddressed mailing envelope was a four page document written in the Arabic language. The envelope and paper appeared to be new and in good condition.

[REDACTED] Al-Attas indicated that this document was his will and that he had drawn it up long ago. He stated that it is the custom for Muslims to draw up their wills early in life and to then carry them thereafter. A copy of the translation of this will is enclosed.

[REDACTED] In the will, Al-Attas writes that "death has approached". He asks to be forgiven for his shortcomings and expresses the hope that "Allah will award him with paradise and keep him with the prophets, martyrs and pious." He addresses his parents with the hope that they will be together in paradise.

[REDACTED] Al-Attas also asks that his parents relay his greetings to "Sheikh/Haj Ahmad Endejai (spelling variation for Ndjeje) who taught me patiently." He advises his parents to follow his teachings and pass them on to their children. Al-Attas closes his will by urging the readers not to ignore the issue of the "woman's veil even for your young daughters. Let them cover with an Islamic attire and don't let them imitate the West..."

[REDACTED] During a subsequent interview of Al-Attas on 08/17/2001, he revealed that he had worked for compensation while in the U.S. He was therefore determined to be out of status by INS and arrested. His bond was set at \$5000.

[REDACTED] While in INS custody on 08/13/2001, Al-Attas made 13 calls to (405) 497-3516, subscribed to by Elhadj Ndiaye, 1408 Cami Drive, Norman, Oklahoma 73071. On the thirteenth call attempt, Ndiaye agreed to accept the charges and engaged in an 8 minute and 53 second conversation with Al-Attas. The transcript of this call is enclosed.

[REDACTED] During this call, Ndiaye states to Al-Attas, "I heard that you wanted to go on Jihad." Al-Attas replies to this, "Sheikh, do not talk about it now. Do not talk about it now, Sheikh." Ndiaye also expresses concern for Al-Attas' welfare, and indicates that he and unidentified others had been unable to sleep for the last few days as a result. He states that Al-Attas had not told him that he was intending to travel. Al-Attas corrects Ndiaye by reminding him that he had said that he might travel.

[REDACTED] For information, Al-Attas admitted during an interview on 08/16/2001 that he would be willing to participate in Jihad in the future. He claimed that he was unable to do so now as he has not yet completed his studies. Al-Attas stated that he would be willing to fulfill this duty once he finished his education.

[REDACTED] Minneapolis believes that Al-Attas is fully involved in Moussaoui's scheme in furtherance of his radical Islamic Fundamentalist beliefs. Based on the content of his will, it is obvious that Al-Attas expected to die in the near future. As he claimed to be in good health and did not indicate that he had any medical conditions, Minneapolis believes that his death would have been caused by whatever he and Moussaoui were intending to do. Minneapolis believes that Al-Attas had recently written his will as a letter of farewell to his family and had placed it in a mailing envelope in preparation for mailing it to Saudi Arabia before beginning his mission.

[REDACTED] Further, as learned from his call to Ndiaye, Al-Attas' travel to Minneapolis was in connection with his participation in Jihad. As can be seen from the transcript of the telephone call, as soon as Ndiaye raised this point, Al-Attas asked him not to discuss this issue on the phone. This indicates that Ndiaye and others at the An-Nur Mosque in Norman, Oklahoma were aware of what Moussaoui and Al-Attas were attempting to do.

I advise you to follow the guidance of the prophet, who delivered the message to this nation...Also, you should act according to the Glorious Quran and the "Sunna" (note: sayings and doings of the prophet). Allah said, "whoever obeys the prophet, he obeys Allah."

I ask you to forgive me for my shortcomings. I don't know whether I am headed for hell or paradise. I hope that Allah will award me with paradise and keep me with the prophets, martyrs and pious.

My dear father and mother, Allah, the exalted, commanded us to respect you and to carry out our obligations towards you. There is no doubt that you exerted lots of efforts raising me according to the teachings of this truthful faith...I urge you to be steadfast as far as Islam is concerned. I hope that we will meet in paradise, god willing.

Would you please relay my greetings to all my sisters and brothers.

Also relay my greetings to the

virtue/sheikh/Haj Ahmad Endeayai, aka Abu
Mustafa, who taught me patiently. I advise you
to respect this sheikh and to follow his
teachings and pass them to your children. I
have not found this man, whom I consider as my
bother and friend, to be arrogant and fanatic...

The last part of my will deals with the
following matter: don't ignore the issue of
woman's veil even for your young daughters. Let
them cover with an Islamic attire and don't let
them imitate the West...

And may peace, blessings and mercy of Allah be
upon you.

The following telephone conversation was initiated by Hussein Al-Attas while in jail. Attas placed a collect call to his Imam, Al-Haj Achmed Ndiaye, (AKA) Abu Mustafa, at the Mosque in Norman, Oklahoma. The collect call was accepted by Imam Ndiaye, and the following conversation took place.

NDIAYE: Hallo! Hallo!
HUSSEIN: Greetings.
NDIAYE: Greetings to you. What happened?
HUSSEIN: How are you sheikh?
NDIAYE: Where are you?
HUSSEIN: Are you alright?
NDIAYE: Thanks to God.
HUSSEIN: I'm alright. Alright. It's nothing.
NDIAYE: Where are you?
HUSSEIN: I'm telling you I'm alright. I'm alright.
NDIAYE: There is nothing by God's willing.
HUSSEIN: There is no power, and no straight save in God.
NDIAYE: Sheikh I just wanted to tell you ...
HUSSEIN: We didn't sleep all night. We didn't sleep
NDIAYE: last few days. We didn't know where have
HUSSEIN: you been.
NDIAYE: Don't worry everything is alright thanks
HUSSEIN: God. Sheikh. What happened. I was waiting

They said that this is a problem, and I shouldn't have taken any money. I was apprehended on this point.

There is no power, and no straight save in God. Yesterday I didn't want to tell you everything. I heard that you wanted to go to Jihad.
