First I want to make clear to your standby lawyer Yamamoto that I consider you as an enemy, who is participating in the conspiracy to killed me.

The fact that I entertain communication with you is dictated by the reality of my situation namely I cannot speak to nobody else, the government has me under seal.

However as I know the self interest american mentality you might decide to distance yourself from the hard core of dirty truckers. (Bunker & Mac & Z). Time will tell if you are wise enough to anticipated the change in the "wind". My aim is to save my life and I am ready to be very flexible to achieve this.

So, here is a list of action that I order to undertake so you might be able to demonstrate a new frame of mind.
