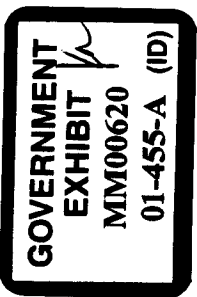

FOR EACH FLIGHT:

Aircraft Rental Agreement

1. I will inspect and make a pre-flight check of the aircraft until I am satisfied as to its airworthiness.
2. I will return the aircraft at the agree time, weather permitting, and will return it in the same condition that I received it, normal wear and tear excepted.
3. I will use the aircraft only for the purpose and over the route specified for each flight.
4. I will observe all federal, state, and local air regulations, and I will fly only within the boundaries of the United States unless prior authorization is approved.
5. I will fly only daylight hours and only in VFR weather unless specifically authorized to do otherwise or if I hold an instrument rating.
6. I will obtain weather reports and forecasts immediately before making a flight out of the local area and will not fly if conditions along my proposed route are forecast to be below VFR minimums unless I hold an instrument rating.
7. I will fly from the left front seat only and will allow no one else to fly the aircraft.
8. I will land only at established airports except as a precautionary or emergency measure.
9. I agree to report all accidents major or minor to Huffman Aviation, Inc. at once, together with names and addresses of witnesses and involved parties. In the event of an accident, I will not permit the aircraft to be moved unless expressly authorized to do so by Huffman Aviation, Inc. or Federal authorities and will do all I can to protect the aircraft and its equipment from further loss.
10. I agree not to tamper with, molest or attempt to repair any part of the airplane equipment or its accessories, but will telephone collect to Huffman Aviation, Inc. for instructions as to what to do in the event of a malfunction of any part of the airplane equipment or its accessories that would prohibit the continuation of my trip.
11. I agree to pay any deductibles of Huffman Aviation Inc.'s insurance policies if I do not have my own non-owned aircraft liability insurance coverage for damage to the aircraft while renting or flying said aircraft, non-moving or in motion.
12. I agree to pay Huffman Aviation, Inc. for any deductibles or losses not covered by Huffman Aviation Inc.'s insurance policies and for any loss or damage to the aircraft caused in whole or in part by my failure to comply with the above, or by my negligence and I agree to, and do hereby indemnify Huffman Aviation, Inc. against any liability to other persons, and any cost, damages, loss, or attorney fees, arising in connection with agreement or with my use of the aircraft not covered by insurance.
13. I agree to pay the published rates for the aircraft that I have rented according to Huffman Aviation, Inc.'s terms.
