FLIGHT SCHOOL CONTRACT

Agreement entered into this Sunday, March 26, 2000, by and between FLORIDA FLIGHT TRAINING CENTER, INC., hereinafter

referred to as FFTC, and Ziad Jarrah, hereinafter referred to as STUDENT. WHEREAS, FFTC provides complete course programs on various levels of ground and flight instruction (PPL through ATP); and WHEREAS, the STUDENT desires to register and contract with FFTC for such instruction. In order to insure training consistent with our standards, ALL training is to be done at FFTC unless otherwise specified in advance and agreed to by both parties. Solo or dual hours flown outside of FFTC's jurisdiction will not count toward the total minimum hours required for sign off, for check-ride. Monies in the students account will be available for FFTC instruction for one year and then will be forfeited unless the time frame is extended, in advance, for due cause. FFTC will use best efforts to provide superior instruction and available equipment.

NOW THEREFORE, IT IS HEREBY AGREED

The parties hereto contract with each other, for FFTC to provide flight instruction to STUDENT, for **Full Program** Flight Certification or _____ hours. The hourly rates charged for dual instruction, solo flight, and ground school with the rental for the various airplanes, are all set forth in the attached Exhibits B and C. The cost of Study Materials, the required written examinations, and the Practical Examination with the FAA shall be in addition to the above fees, and shall be the responsibility of the STUDENT. The FFTC makes no guarantees as to the number of hours required to complete the training for the specific flight certificate STUDENT is seeking. The time and cost of the training will vary for every STUDENT and an exact amount for completion of each course cannot be predetermined. Attached hereto as Exhibit B, is a list of examples, based on the minimum requirements to obtain various flight certificates. Attached hereto as Exhibit C is a list of the hourly charges for the rental of various airplanes in connection with instruction. The STUDENT warrants to FFTC that STUDENT is in the proper physical and mental condition to participate in the flight training program the STUDENT is registering for. STUDENT is required to obtain a medical examination at STUDENT's expense, and provide FFTC with a copy of said examination. FFTC reserves the right to refuse training or to terminate the training of any STUDENT should it be determined that the STUDENT is not physically able to participate or continue said training. STUDENT releases and indemnifies FFTC from any and all claims, causes of action, damages, and injuries growing out of STUDENT's mental or physical incapacities or conditions. The STUDENT shall at all times observe and conform to all Federal, State, County, and Municipal laws, ordinances and regulations, including, but not limited to rules and regulations of the FAA. The STUDENT agrees to and shall comply with all of the terms and conditions contained in the attached Exhibits, which is specifically incorporated by reference herein. Should the STUDENT violate any of the terms contained in this agreement, of any of the attached Exhibits or should the STUDENT refuse to follow the directions of FFTC or any instructor associated with FFTC or cancel the course he / she signed for, then and in that event, FFTC shall have the right to terminate this agreement and cancel all future instruction with the STUDENT. To compensate the costs, produced by cancellation of program(s), FFTC shall have the right to charge a cancellation fee of US \$ 100.- for each course the STUDENT signed for and additionally retain the Deposit for none finished course(s).

This account is fully refundable UPON COMPLETION OF THE COURSE (S) CONTRACTED FOR. Failure to complete will result in forfeiture of the minimum balance 365 days from the date of the students last flight with FFTC. Should the balance fall below the minimum, FFTC reserves the right to draft against the students credit card to bring the account to minimum level.

A Non-refundable **ENROLLMENT FEE OF US \$ 150.-** for each individual program to **A MAXIMUM OF US \$ 500.-** will be charged to you credit card. Course(s) of study of greater than 90 days will require US-Visa. After the STUDENT has signed this contract and paid the required deposits and enrollment fees, FFTC shall provide STUDENT with the forms and paperwork necessary for STUDENT to apply for a Visa.
